## **PROGRAMMATIC HIGHLIGHTS**

- The season kicked off with a musical collaboration with Broadway composer Dave Malloy on Beowulf: A Thousand Years of Baggage and ended with a collaboration with director Mark Valdez on a new adaptation of Lope de Vega's Fuente Ovejuna. Both productions filled the Chace Theater with rousing music, great acting, and innovative stagecraft.
- Director Kent Gash's extraordinary staging of Katori Hall's The Mountaintop thrilled audiences with its intimate tale of Dr. Martin Luther King Jr.'s encounter with an angelic hotel maid. Company members Joe Wilson, Jr. and Mia Ellis gave bravura performances.
- Tyler Dobrowsky's brilliant version of A Midsummer Night's Dream wowed subscription audiences in the Chace Theater. The production, set at a 1980s prom complete with live '80s music, was visually delicious and utterly delightful from beginning to end. In addition, in celebration of Project Discovery's 50th Anniversary, the production served as the centerpiece of the Grade 11 Project, which invited every 11th grader in the state of Rhode Island to see the show free of charge, creating a statewide conversation around Shakespeare. Nearly 7,000 students saw this fantastic production.
- Trinity Rep's community conversations continued to deepen and broaden in 2016-17, with the return of the Every 28 Hours plays. This program was a great success with audiences once again, playing to packed houses. In addition, workshops and community discussions with local universities and City of Providence convenings took the conversation to a whole new level.
- Trinity Rep launched Shakespeare en el Verano, providing free outdoor performances of a new bilingual adaptation of Shakespeare's Romeo and Juliet at locations throughout Providence.
- Educational programming and impact continued to grow. TRAIN: Trinity Rep Active Imagination Network served 600 students from Bradley Hospital's Adolescent Inpatient Unit, The Autism Project, Hasbro Children's Hospital Partial Hospitalization Program, Seven Hills Rhode Island, ProAbility, and Bradley School; and Creative Classrooms Arts Integration programming served 500 students at Asa Messer and Carl Lauro Elementary Schools.
- The Brown University/Trinity Rep MFA Program continued to rise in the annual college rankings. College Choice ranked Brown University as #10 in the country among all MFA programs (#5 among those schools with MFAs in Theater/Drama/Performance). *The Hollywood Reporter* rated the program the #6 acting program in the world (#5 in the U.S.). OnStageBlog rated the program #9 among MFA acting programs.

### FINANCIAL Highlights

Trinity Rep achieved positive cash flow from operations for the first time in over a decade. Unrestricted operating results, including non-cash depreciation expense, improved \$820,120 to an operating loss of (\$167,127) or -1.7% of functional expenses in FY2017.

Total operating revenue, support, and releases increased 8.7% (driven in part by 26.7% growth in unrestricted cash contributions), and total operating expenses decreased 0.6%.


The organization restructured and consolidated its long-term debt in FY2017. Total loans payable on June 30, 2017 was \$1,706,248.


- The accumulated operating deficit decreased from (\$2,135,252) in FY2016 to (\$1,676,571) in FY2017.
- New endowment contributions of \$239,220 and investment gains brought total endowment and quasi-endowment assets to \$2,474,302 on June 30, 2017.
- Capital contributions of \$1,005,480, mainly from the Rhode Island Cultural Facilities Bond, funded the first phase of a HVAC system replacement, emergency generator, and the first phase of the Dowling Theater renovation.
   Total net assets increased \$918,682 in FY2017, compared to a decrease in total net assets of (\$729,098) in FY2016.

# ABOUT TRINITY Repertory Company

Trinity Repertory Company's mission is to reinvent the "public square" with dramatic art that stimulates, educates, and engages our diverse community in a continuing dialogue. Since its founding in 1963, Trinity Rep has been one of the most respected regional theaters in the country. Featuring one of the last longstanding resident acting companies in America, Trinity Rep presents a balance of world premiere, contemporary, and classic works in its two venues: the 500-seat Elizabeth and Malcolm Chace Theater and the 250-seat Sarah and Joseph Dowling , Jr. Theater. As Rhode Island's largest arts organization, Trinity Rep has a significant impact on the community and is a linchpin of Providence's arts and entertainment district. Trinity Rep has produced a number of celebrated world premieres, mounted national and international tours, trained hundreds of new actors and directors through its MFA programs (now in association with Brown University), and has consistently been a pioneer in arts education for people of all ages and abilities. The Brown University/Trinity Rep MFA program has become a leader in graduate training for actors and directors by offering in-depth classroom work in conjunction with a professional theater, and is widely regarded as one of the best in the country. Since 1973, Trinity Rep's home has been the Lederer Theater Center, a historic landmark built as the Majestic Theater in 1917. In 1981, Trinity Rep won the Regional Theater Tony Award, and in 2014, it was named the State Theater of Rhode Island.
